Conditions of Use:

1. This form is valid for 7 years from the date you sign it, or for the period of time your child attends this school. The consent will automatically expire after this time.
2. We will not re-use any photographs or recordings after your child leaves this school.
3. We will not use the personal details or full name of any child or adult in a photographic image on video, on our website, or in any of our printed publications.
4. We will not use the personal details or name of any child or adult in a photographic image on our school social media platform.
5. If we use photos of individual pupils, we will not use the full name of that child in the accompanying text or photo caption.
6. If we use photos of individual pupils, we will not use the full name of that child in the accompanying text or photo caption on our Social Media platform.
7. We will not include any personal email or postal addresses, or telephone number on video, on our website, on our social media platform, or in any printed publications.
8. We may include pictures of pupils and teacher that have been drawn by the pupils.
9. We may use group or class photographs or footage with very general labels, such as 'a maths lesson' or 'Year 6 residential trip'.
10. We only use images of pupils who are suitable dressed, to reduce the risk of such images being used inappropriately.
